I have known and worked with and for Dr. Fred A. Brooks for almost two decades, and now use him as a consulting park and recreation expert for my company, Land Image, Landscape Architects. More importantly to me, and, I believe, to the recreation and parks profession, particularly to CPRS District II, I am pleased to nominate Dr. Brooks to receive your District II, Hall of Honor Professional Award. Having graduated from CSU, Chico and UC Davis, and having worked with CPRS programs and professionals for over two decades, I without hesitation, state that Dr. Brooks is an exceptional and unequalled educator along with being unmatched as a committed park and recreation professional.


As a Horticulture major, I first met Dr. Brooks when I took his Design of Recreation Areas and Facilities course offered via the Recreation and Park Management Department at CSU, Chico. At that time I knew virtually nothing about parks and recreation except the activities in which I participated and enjoyed. Taking that course, learning the course information and applying the skills taught in the actual design of a real recreation facility, Clotilde Merlo Park, was the turning point in my career preparation and realization...of being a very successful landscape architect.

Knowing of my interest in recreation and facility planning and design, Dr. Brooks continued to involve me in his recreation and park planning and design field projects for agencies in CPRS District II. During the summer and winter vacations, along with other students, I helped him with the evaluating, mapping and creating master plans for the recreation areas owned by the California Tahoe Conservancy (CTC) and for the Lassen National Forest (LNF). With my experience and skills learned, Dr. Brooks also involved and employed me to help him and his students design projects in District-II. I later used copies of this work for my portfolio to be accepted in the Landscape Architect Program at UCD. Dr. Brooks, without pay, tutored me in any way I desired. He had the contacts to get me admitted to UCD where I graduated at the top of my class. Many of the recreation facilities on which we worked were subsequently funded and are now developed. My senior project was a master plan for the now developed CTC "Carnelian Bay Recreation Area" in North Lake Tahoe.



Nominee: Dr. Fred A. Brooks, Emeritus Professor, California State University, Chico

### Professional Category Criteria and Significant Contribution Evaluation Criteria:

- Dr. Brooks exemplifies the principles, values and high moral character of recreation, park and leisure profession and has taught these through his example and the training of hundreds of current recreation and park professionals.
- Dr. Brooks was an exemplary practitioner as a leader, supervisor, administrator and an Educator in Recreation, Park, and Leisure Services in the public, private and education sectors for over five decades. (see resume and accomplishments in CPRS District II summary. His accomplishments beyond D-II exceed this.)
- Dr. Brooks retired from full-time employment in January 2000 from California State University where he was awarded “Emeritus Professor” status, the highest honor a University and his university colleagues can bestow upon a distinguished professor.
- Dr. Brooks has worked in and served our profession for over 50 years.
- Dr. Brooks worked in and served in CPRS District II for over 35 years.
- Dr. Brooks has made significant professional contributions in all of the following:
  - Dr. Brooks has been a recreation teacher and trainer since he was a student at SJSC preparing to enter our profession. He was vice-president of the student section and in-charge of student training programs. At that time, 1957, he was the recreation leader of the largest elementary school recreation playground program in the City of San Jose where he trained many student Jr. Leaders and parents to assist him in conducting his programs. Some of his playground student assistants have worked in and retired from parks and recreation. As a student, he chaired his first CPRS Conference session re “Careers in Recreation and Parks” in San Jose in 1959. He trained and taught his staff, professionals working under him, professionals in CPRS and their staffs at CPRS training programs, students and volunteers in every phase and level of his professional career. As a professional educator he trained and assisted hundreds of students working in our and supportive professions.
  - Dr. Brooks has provided the outstanding leadership in every position he has held and for over 100 professional recreation planning, design and operational projects for agencies and operations in CPRS District II. Just a few of these have been highlighted in his accomplishments summary. See brochures: i.e., all recreation areas and facilities on the USFS LNF and Clotilde Merlo Park.
  - He has received awards and commendations for his many projects including a commendation from the President (Reagan) and the LPC for his design and supervision of the construction of Merlo Park and having the CSUC Research Foundation and the USFS LNF name the marina at Eagle Lake in his honor. He has also received awards for his Meritorious Service from CPRS for his outstanding professional service and accomplishments and for his leadership of the CPRS Scholarship Foundation Board (summary in accomplishments).
  - Dr. Brooks’ written and education training materials prepared, presented, published and used in his work and teaching are too extensive to list here.

## Dr. Fred A. Brooks...Specific Professional Accomplishments in CPRS District II

Dr. Brooks, a living legacy in the field of parks and recreation, has been an outstanding leader in our profession for over five decades ('56-'08). The positive impact of his work in each position he has held has been outstanding. He is a contemporary to the two men inducted into the CPRS District II "Hall of Fame" in 2007, William Pond and Ed Maheny and voluntarily assisted them both via his professional knowledge and work. He declined the offer from Bill Pond to become the Chief of Recreation Services for Sacramento County to assume the position of Recreation Director for the City of Davis; however, he voluntarily assisted with design work on the American River Parkway, including helping with the design of Discovery Park. A career long friend and supporter of Ed Maheny, he encouraged and assisted in the development of the parks and recreation master plan for the City of Roseville that has led to its outstanding facilities and services. He assisted the landscape architect in the design of Maidu Community Park in Roseville. Some of Dr. Brooks' former students now work in administrative positions in the City of Roseville.

Dr. Brooks was employed by the City of Davis to be the City's Recreation Director in 1969. At that time the department shared one secretary with the City Manager, had three staff members, there were four modest City parks, the start of a bicycle path program, a very meager budget, a modest sports program, problems with many teenagers labeled "the street people" and no cultural or senior programs or facilities. In four years' time, Dr. Brooks organized the department first into the Parks and Recreation Department and in 2003 into the Department of Parks and Community Services. Working with City residents and leaders, he developed and had approved a Parks and Recreation Master Plan, with funding, for the City. Where no bonds for park and recreation facilities had ever been approved in the City, he organized and worked with residents and leaders in the City to develop a bond program to provide facilities for all ages, interests and abilities. He organized and mobilized City residents down to the neighborhood block level to support a parks and recreation facilities bond measure that was approved by the largest margin of any such election in CA history, by over 80%, in each precinct in the City. The bond issue provided a full range of parks and recreation facilities...community recreation center and theater, aquatic complex, tennis and sports complexes, bike/exercise trails, etc.

Dr. Brooks worked with the City officials to fund a teen and a senior program if he could find facilities for these programs. He was able to get City Council approval to convert a former City Library to a Teen Center. He worked with the teens and community, without a facilities budget, to convert the building. Upon completion, he received special City Council funding to staff the facility and to provide programs for teens. He befriended the daughter of the founder of the Bank of America. They worked together to see that a new B of A was approved and that the existing B of A was converted for a temporary senior center. The City Council then approved funding for a Sr. Programs Director and program.

By 1993, Dr. Brooks had an executive secretary and four other full-time clerical workers to handle the immense volume of the City's recreation programs. In taking over parks and facility operations from Public Works, he hired a parks superintendent and developed an outstanding street tree, parks and facilities maintenance program. He also hired a recreation superintendent and had five full-time recreation supervisors heading all aspects of a comprehensive recreation program. He developed a good joint use agreement with both the schools and University of California, Davis. By 1993 the Parks and Community Services budget was the largest of any of the City departments. Dr. Brooks had lined up the city leaders and council votes to get all his requests approved. Dr. Brooks' good work

and vision wasn't limited to the City of Davis, its bikeways and the establishment of sound park dedication, impact and maintenance fees there. He also helped many CPRS District II cities and districts with their park and recreation planning and design needs.

Dr. Brooks met with leaders of the residents of what now is the City of Elk Grove and worked with the CA P&R Department to help them develop a plan and to get approved what was then the Elk Grove Community Services District, now the Cosumnes CSD. He helped the planners working with the City of Roseville Parks and Recreation Master Plan and the Sacramento County planners of the American River Parkway. He helped Royston, Hanamoto, Alley and Abey, and Ribera and Sue with N.E. CA. projects. He also helped with the creation of the Yolo County Parks Dept. (Earl Balch, Director then) and wrote a successful grant for Yolo County to acquire over 300 acres of BLM parkland. He did the master plan for the Durham CA, swim pool complex and other D-II facilities. When Dr. Brooks left the City of Davis most of the recreation facilities and bikeways that exist there today were planned, developed or being developed. Later, he enjoyed taking his planning and parks students to Davis, Roseville and other areas to tour their facilities.

Dr. Brooks left Davis to become Vice President of Lampman and Associates, the largest consulting firm to districts and local government in CA at that time. There he worked with Jack Harrison to direct the parks, street tree and recreation facilities planning division. While there he planned parks for the City of Sacramento (Valley Hi) and other CA cities and districts and worked on master plans for cities, counties and districts in District II. Dr. Brooks wanted to teach and share what he had learned and his successes in parks and recreation with those in and entering the parks and recreation profession. In 1994, he was accepted into the Educational Administration doctoral program at BYU. He was there recruited to be the administrator for the newly formed Utah County Parks Department. He retained his recreation consulting work with firms working in CPRS D-2.

Completing his doctorate with great distinction and having completed the Master Plan for Utah County Parks, in January 1976, Dr. Brooks was hired to be a Parks and Recreation Instructor and to head the Parks and Natural Resource Management program at CSU, Chico. He started writing successful grants and contracts to augment the PNRM budget, to provide his students with practical field experiences, to financially help CSUC and to help our park and recreation field professionals. Over the span of his tenure at CSUC he averaged approximately a \$1,000,000 a year in grants and contracts. He and his graduate and undergraduate students completed over 100 park area and area-wide master plans for cities, districts, counties, CA agencies, fairgrounds and private firms in District 2 from the greater Sacramento Area to Yreka. One private project was the planning of Clotilde Merlo Park in Sterling City, featured in Sunset Magazine, for the Louisiana Pacific Corporation. He was later hired to supervise the construction of that facility. At a time when the California-Tahoe Conservancy had very limited funds, the Director of the CTC employed Dr. Brooks as the advance planner for the CTC, where he had former students working. Working with his students he surveyed and master planned all of the CTC recreation projects that have been and are to be developed adjacent to Lake Tahoe. Dr. Brooks and his students received over 100 commendations and awards for their projects.

In 1982, Dr. Brooks wrote a successful proposal to manage all of the recreation resources on the Lassen National Forest, including the Almanor, Eagle Lake and Hat Creek Districts, providing over 1,000 recreation sites and facilities. He designed and oversaw the construction of the marina facilities at Eagle Lake, which were dedicated in his honor

in 2003. For 20 years he directed and operated, with his undergraduate and graduate students, the most successful USFS permit recreation facilities management program in the U.S. From 1982 to 1990 he conducted playground safety training for D-II cities and districts. When he joined the CSUC faculty the Department of Recreation and Parks had internal conflicts, with administrative threats of discontinuing the program due to budget cuts. The Dean of the College asked Dr. Brooks if he would chair the Department if so elected by the faculty. Dr. Brooks was unanimously elected to Chair the Department. Under his leadership the Department was pulled together, enhanced its program status on campus, completed materials for accreditation, was fully accredited, and, with the strong support of the CSUC Administration, added outstanding faculty, programs and facilities. It became one of the outstanding university recreation and parks programs in the U.S.

In 1989 Dr. Brooks took a 7 month sabbatical to be the acting Director of Parks for the City of Chico. In that position he completed the first 2,400+ acre Bidwell Park Master Management Plan and plans for the various areas and facilities needed in Bidwell Park.

After he joined the CSUC faculty, Dr. Brooks was appointed by CPRS to represent CA educators on the Scholarship Foundation Board. Following the passage of Prop 13, CPRS was financially forced to eliminate providing college scholarships. With that decision, at the 1979 CPRS Conference in Fresno, the chair of Scholarship Foundation Board resigned. Jack Harrison, then Executive Director of CPRS, called Dr. Brooks and asked him to chair the Board and challenged him to make the CPRS scholarship program better than ever. Having received the first, and, at the time of his graduation from SJSC, the only graduate studies scholarship offered by CPRS, the Alta Sims Bunker Scholarship, personally presented by her, Dr. Brooks realized the importance of the CPRS Scholarship program. Calling upon CPRS sections, businesses and others (to honor former CPRS professionals), while chair of the Scholarship Foundation Board, he built the scholarship program up to 32 undergraduate and graduate scholarships, and to be the finest park and recreation professional society scholarship program in the U.S. As chair he also facilitated the process of receiving the funds for the CPRS offices in Sacramento. Over the years Dr. Brooks strongly supported and trained students for Parks Operations work. Following his retirement, at the 2000 CPRS Conference in Sacramento, the CPRS Parks Operations Section, dedicated its scholarship to be presented in his name and honor.

Dr. Brooks was a professional colleague and contemporary of Dr. J.R. "Shockey" Needy. Many years ago he received the District 2 Professional Award given in Dr. Needy's honor. Dr. Brooks has received awards from CPRS, CSUC, the USFS, CA State Parks and Recreation, CA natural resource agencies (CTC and others) and departments for his professional work and accomplishments. He has also received awards and recognition from the many, many public programs and agencies he has helped with the planning, design and the realization of excellent recreation facilities and programs...dating back to 1957. While all of Dr. Brooks' professional, living, contemporaries have retired, as have most of his former staff and some of his students, Dr. Brooks continues to serve our profession and his community. He has provided professional materials and scholarship funding to CPRS and D-2. In December 2006, he was elected by the largest plurality vote for any candidate running for elected office in Butte County, to be a Director on the Chico Area Recreation and Park District Board of Directors. Dr. Brooks was recently elected by the Special District Directors in Butte County to the Executive Board of the BCSDA (association). His "visions" and realizations of the positive potentials of parks and recreation facilities continue with him and with his numerous professional protégés.

was picked because of the locality. There are no homes adjacent to the fill; thereby eliminating the noise factor. The site is surrounded on one side by the San Leandro basin estuary, the other by the golf course, and the rest by fill area, and the golf course.

The site was unusable at first without some clean dirt fill added on top of the present fill. This was accomplished by donations from local construction companies, the disposal company, and golf course dredging. The disposal company and golf divisions spread the top fill and constructed two tracks. One was 1,700 feet for the experienced rider; the other, 1,500 feet for the novice.

Use and rules were then established: only 90cc bikes and less are allowed on the course. Each rider is required to sign a rule sheet and parents sign a use permit. All riders must wear shoes, helmet, and gloves; riders must be 8 years of age and older; all bikes must have brakes; and all riders must obey basic traffic courtesies.

The fee established was: residents 8-15 free, and 16 and over, 50¢; non-residents 8-15, \$1.00, and 16 and over, \$1.50. All fees are for one day's use.

Obtaining insurance was the next step. Blake Palamountain Agency of San Leandro offered a policy to insure the facility, \$100/300,000, and P.D.

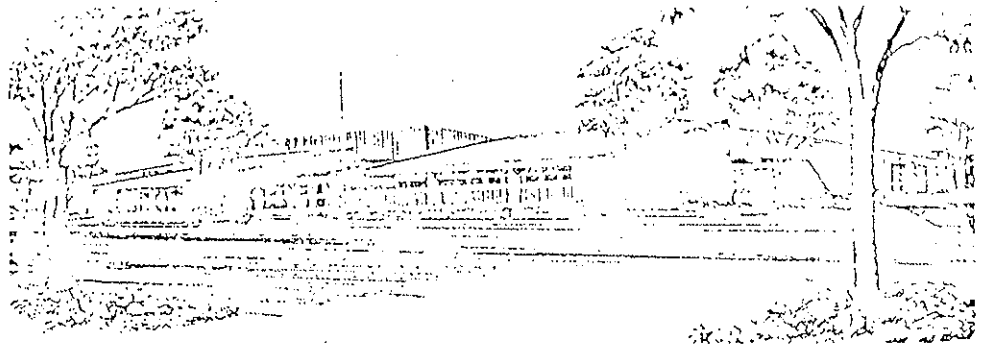
\$100,000, with a secondary coverage to extend liability to \$1,000,000. The total yearly premium for this \$100 deductible policy is \$2,650.

Leadership was obtained through local advertising. Two leaders were hired who held the qualifications of (1) holding a first aid card; (2) had motor bike experience (one is a professional bike rider); (3) be able to relate to people; and (4) have some motor bike repair experience.

During the first four months' operation on weekends and school holidays, 312 different riders registered, with an average of 22 attending on Saturdays and 30 on Sundays.

The reaction of the public to the park has been outstanding. Many adults have offered help in the maintenance and control of the facility as a chance to help plan the program, as well as having a family activity.

When the program began there was some apprehension regarding noise, air pollution, and riding on sanitary fill. The only present problem is making sure that there is plenty of extra fill on top of the garbage. Many times the use of sanitary fill brings some adverse comments, but with an "unwanted" activity such as mini bikes, this became the ideal solution for the use of "waste" land.



## Davis Votes Overwhelmingly 'Yes'

In the midst of defeats of bond issues at all levels throughout the state, in April the people of the recreation-oriented city of Davis overwhelmingly approved a citizen-drafted bond program consisting 100 percent of recreation facilities. They also elected a city council majority running on a "Quality of Life" platform.

The approval of these issues was given despite the fact that salaries at the University of California at Davis, to which the town is focused, have not been raised in three years and there is literally no industry or tax base in the city to help shoulder the cost for the individual property owners.

By a locally unprecedented 81.3 percent "yes" vote, the people in this city of 27,700 (with over 22,000 registered bicycles) approved in every precinct three separate bond items. These included five new neighborhood parks, a community center complex, and a swimming complex.

The design and improvements of the parks varies; however, each reflects a plan arrived at as a result of citizens committees representing the neighborhoods to be served working with a landscape architect and the city staff. The only specific improvements generally in common between the parks is the inclusion of children's play areas (although they vary in size and design) and tennis courts that will make a total of 24 night-lighted courts available to the community. The average improvement cost per acre, not counting land purchase, is approximately \$33,500.

The community center (pictured above) includes a slant-floor performing arts theatre with continental seating; youth activity and game rooms; a large multi-use room for dances, banquets, etc., that is dividable for smaller activities; three separate studios for ceramics and sculpture, handcrafts, and art; club and meeting rooms for these activities as well as preschool, dance, and other programs; various

patios, kitchen, reception, registration, office areas, and storage. The building is designed so that rooms may be added.

The swim complex will consist of at least three separate pools to accommodate the full range of pool users from tots to competitive programs—with the emphasis on recreation in design and function. The initial value of these facilities is close to three million dollars.

Recreation and Parks Director Fred Brooks attributes the success of the bond election to (1) endorsement of the current program and services; (2) citizen involvement in conducting current programs, in determining recreational needs, and in planning for programs and facilities to meet these needs; (3) support of both the existing program and the bonds by city administration, council, and all candidates running for city council; (4) endorsements by all key groups in the community — the Taxpayers Association, Chamber of Commerce, League of Women Voters, PTA, etc.; (5) the good work record and leadership of the Recreation and Parks Commission; (6) well-written bond arguments; (7) a well-planned bond program and campaign; and (8) hard work by a task force of citizens who went to every dwelling unit to disseminate bond issue information and to get out the vote.



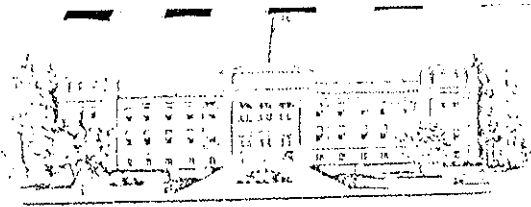

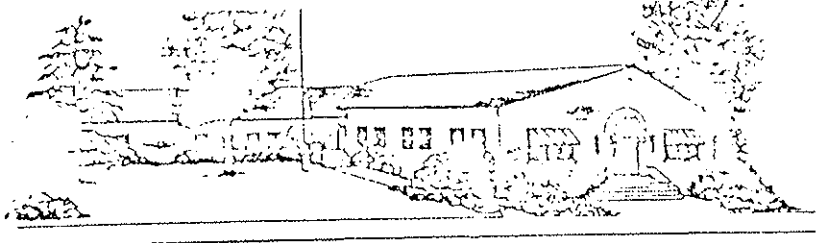
Again thanks for your help in the development of County-wide park and recreation facilities. Keep up the good work.

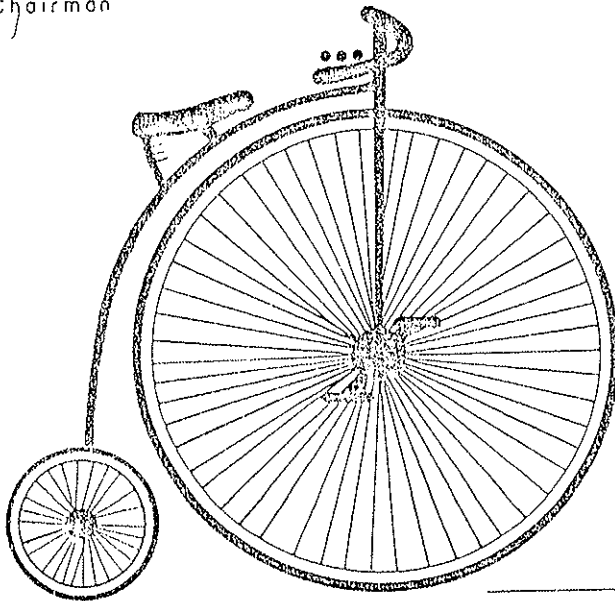

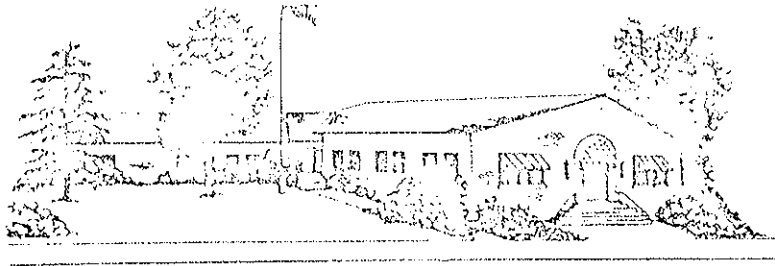
